7 4) (2017) That the Institution shall charge only such fee as the affiliating body/State prescribed by concerned in accordance with provision of NCTE (guidelines for Regulation of tuition fees and other fees teacher chargeable by unaided institutions) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.
