Sub: Affiliation of B.Ed. Course to Dhamait Sikshak Sikshan Mahavidyalaya from the academic session 2014-2015.

Dear Sir.

I have been directed to inform you that on receipt of the recognition letter of N.C.T.E. (No. ERC/7-170.6.17/NCTE/B.Ed./2014/24382 dated 03.03.2014) and subsequently the approval letter of the Higher Education Department, Govt. of West Bengal (No. 858(2)-Edn(CS)/4C-76/13 dated 11.11.2013), the Hon'ble Vice-Chancellor has considered the Inspection Report submitted by the duly constituted Inspection Team regarding affiliation to B.Ed. Course of Dhamait Sikshak Sikshan Mahavidyalaya, Dhamait, in the district of Purba Medinipur which will run the course from the academic session 2014-2015 subject to the fulfillment of the following terms & conditions. The matter has been ratified by the Seventh Executive Council of Vidyasagar University in its meeting dated 27.05.2014.

The terms & conditions of affiliation of the above course:

- 01. The intake capacity at the initial stage for the above mentioned course is 100.
- 02. Students will be admitted purely on merit basis and the admission be made by the University centrally through counselling.
- 03. The College must have to maintain 200 (two hundred) working days in each academic session.
- 04. At least 1 (one) whole-time qualified teacher in each subject is to be appointed immediately on receipt of the affiliation letter. Joining letters to be submitted to the University within 15 days alongwith a declaration that they are not engaged in any other institution.
- 05. At least seven(7) full-time contractual teachers and Part-time teachers are to be appointed before commencement of the said course.
- 06. The full-time Principal of the College must be appointed as per norms of NCTE.
- 07. The college must abide by the Vidyasagar University Act, Statutes, Ordinances, Regulations etc. as amended from time to time.
- 08. The college must abide by the norms of the N.C.T.E. in this connection.
- 09. The college must build up a Reserved Fund of Rs.20,00,000/- (Rupees twenty lakhs) only within one year.
- 10. Books & Journals worth Rs.1,00,000/- (Rupees one lac) only (both for english and Bengali version) for different subjects as per the revised syllabus are to be procured by the college.
- 11. Subscription of Journal (at least Five Journals) are necessary.
- 12. The following method subjects have been granted to Dhamait Sikshak Sikshan Mahavidyalaya for the session 2014-2015:
 (a) Bengali, (b) English, (c) History, (d) Geography, (e) Mathematics, (f) Physical Science, (g) Life Science, (h) Sanskrit, (i) Education, (j) Economics, and (k) Work Education.
- 13. Play Ground and facilities for outdoor and indoor games to be developed at the earliest.
- 14. Facilities for cultural activities to be created and maintained by the college.
- 15. Rs.1,500/= (Rupees one thousand five hundred only) per student per annum to be deposited by the college to the affiliating University.
- 16. In addition to the existing laboratory equipments, more equipments for different laboratories are to be purchased. Adequate number of Computers and other Lab. equipments are to be purchased. Necessary infrastructural facilities like, bench, desk, chair & tables are to be developed.

- 17. An one-time Affiliation fee along with the Sports fee is to be paid which will be decided by the University authority and to be communicated later on.
- 18. Separate class rooms for method subjects are to be provided.
- 19. Common Room will have to be provided for the students.
- 20. An undertaking on a Non-Judicial Stamp of Rs.50/- as per the prescribed proforma available in the office of the Inspector of Colleges is to be made by the college authority regarding abiding the Rules and Regulations of the University in this regard.
- 21. The affiliation of the University shall remain valid so long as the college enjoys the recognition of the N.C.T.E.
- 22. Original copy of the recognition letter of N.C.T.E. and the No Objection Certificate of the State Government must be produced to the University within fifteen days from the date of receipt of this letter.
- 23. The college will have to submit a compliance report to the University after fulfilling the above conditions on receipt of which formal affiliation will be extended.

An early reply accepting the terms and conditions of granting affiliation of the above mentioned course at the Dhamait Sikshak Sikshan Mahavidyalaya should reach the undersigned within fifteen days from the date of receipt of this letter with a copy to the Inspector of Colleges.
